SPRING IS COMING...

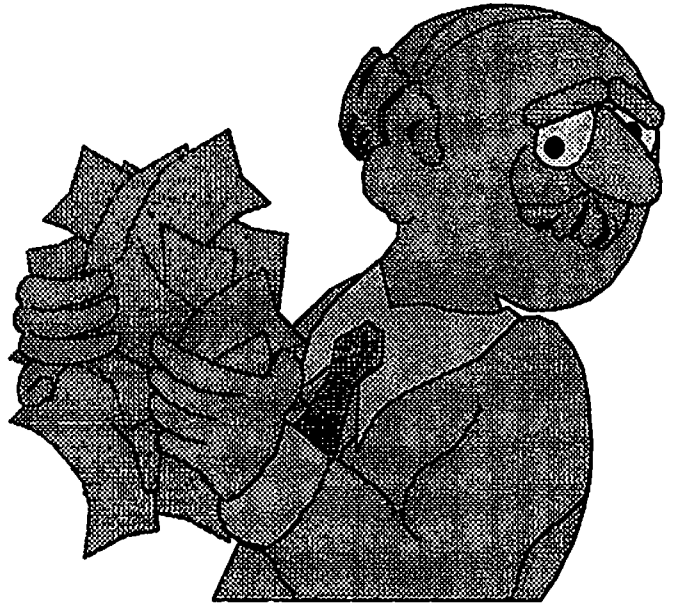
Now that the weather is getting warmer, it's time to do the projects that we have talked about and then selected as high priorities in this year.

The early payments provided The Board with the cash flow to pay \$50,000 on January 17, 2001, of our \$63,694.39 October payment in advance. This resulted in **SAVINGS OF \$3,756.12** in interest charges to Malvern's members this year. (And thanks, too, to Bob Schantz, for keeping track of our finances so carefully!)

ACTED UPON.

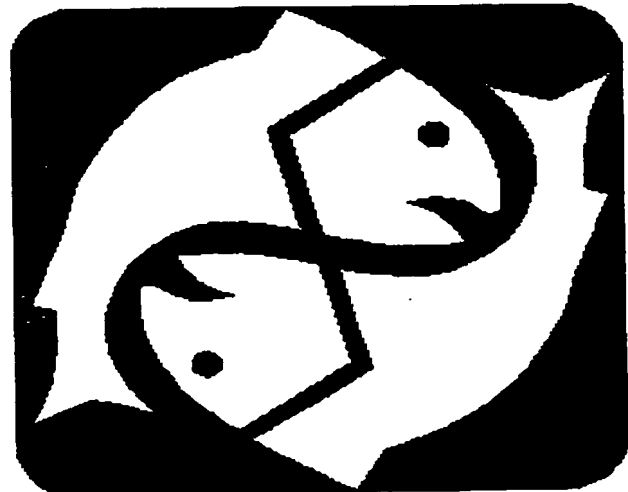

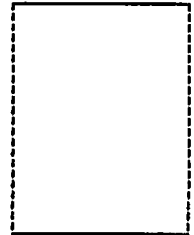
