## FROM THE DESK OF BILL

### Lake Madison Dam Repair

Thank you Bill Hunt and Frank Sargent

Faulconer Construction repaired the Lake Madison dam in July. This involved installing a corrugated and perforated drain pipe at the toe of the dam, constructing a settling basin to run into the creek, and adding soil to the dam face. They had riff raff left over, and this was used to build a channel from the spring by the South edge of the dam to the settling basin. Faulconer then had the debris ground up and the area seeded. Bill Hunt and Frank Sargent represented Malvern Club on the dam. Faulconer did more than was required and completed the job on time. Clearly, Bill and Frank did an excellent job. The dam will be inspected regularly. The drain pipe will have to be replaced eventually. Thirty years has been mentioned as a reasonable drain pipe life.

### Malvern Club Needs Volunteers

Everything in Malvern belongs to the members. We are a self-governed and self-funded community. Our dam, culverts and roads are paid for by us, and not by the State or the County. Our roads don't even show on the maps given away by the realtors. The things we like about Malvern reflect the time and money we put into the community. The things we don't like reflect things we do poorly or not at all.

Maintaining what we like and fixing what we dislike requires work from the members of the committees and the board that would normally be done by state and local government. The normal course of development would have people serve on the committees and to learn how the committee functions under experienced committee chairmen. Then they would run for the board and be eligible to serve as committee chairmen. Instead, four of the six members of the board are serving their first terms in any capacity in Malvern. This includes the President, me. We have one vacancy and two people who have served before. To maintain the community we need people willing to serve on the committees and move up to the board. Please contact a board member, tell them your interests, and we will find a way to accommodate you.

### The 2006 Budget

The loan for the dam repair is a new expense. There isn't a new source of revenue to balance it. Available money will be used to extend the paved roads. The Treasurer made an allowance for increased oil prices which will directly affect paving and energy costs, and will indirectly increase other costs where transportation is a factor. The detailed budget will be presented at the Fall 2005 Board meeting.

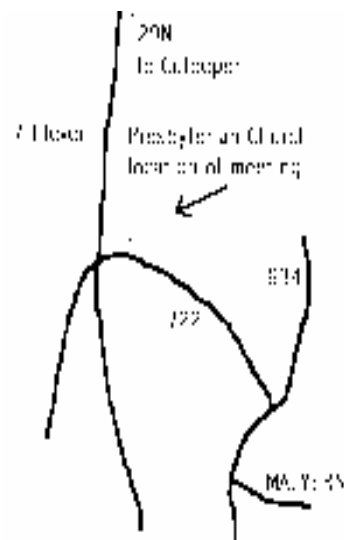
## ALERT TO HIGH SCHOOL STUDENTS

### Grandma's Recipe The Frittata

#### Ingredients

- 2 Tbs olive oil
- Your favorite omelet fixings
- 1/4 cup Parmesan cheese
- 1/2 cup chopped Italian parsley or cilantro
- 4 oz crumbled goat cheese
- 4 eggs or equivalent Egg Beaters
- 1/4 cup milk or soy milk
- salt and pepper to taste

#### Instructions

Sauté your favorite omelet fixings in olive oil in oven safe frying pan until soft.

In a bowl, whisk eggs, milk, salt, pepper, parsley and Parmesan cheese until frothy.

Pour egg mixture in frying pan over cooked omelet fixings. Add crumbled goat cheese evenly over top of eggs.

Place 6" under broiler until browned.

Serve immediately.
